

# Murderer denied parole

Convicted murderer Mark Headley has been denied parole until January 2021. It was a close call.

Letters from concerned citizens, current and former members of the Barberton police, and the family of the murder victim, may have made the difference.

Headley appeared before the parole board March 11, however, “the first hearing the panel couldn’t all agree, so they sent it to the next level,” said Teresa White, the sister of murder victim Sandy Burger, who died from injuries after Headley viciously beat her in 1982 in his Barberton residence.

After a second hearing, “that’s when they reached this decision,” said White.

Burger’s family was informed by phone and in letters by the Notification Unit of the Ohio Department of Rehabilitation and Correction. A letter dated March 13 stated, “The panel was unable to render a final, majority decision at the aforementioned release consideration hearing and therefore forwarded the

case to the Central Office Board Review for further review and consideration.”

A second letter dated March 21 stated, “It was the decision of the Ohio Parole Board to deny the offender parole at this time.”

Headley had been sent back to the Marion Correctional Institution after serving time in Florida

for driving drunk and crashing into a sheriff deputy’s car in 2012. This crime was in violation of the terms of his five-year parole, granted in 2007 after serving 25 years in prison for the murder. The original 15 years to life sentence was issued after Headley had agreed to a plea deal in which he pleaded guilty to Burger’s murder.

# Cleavenger released days after arrest

Todd M. Cleavenger pleaded not guilty to charges of obstructing official business, hit-skip and possession of marijuana in Summit County Common Pleas Court.

Cleavenger, 42, former owner of the Fast Lane bowling alley and The Garage Bar in the Magic City Plaza, was released from custody March 28 after he was arrested March 24.

A \$5,000 bond was set by Barberton Municipal Court Judge David Fish. According

to the Summit County Clerk of Courts website, his bond was revoked March 26. His pretrial is set for Wednesday, April 17 at 9 a.m.

Prior to the arrest, he was involved in a single-vehicle accident on Interstate 77 North. The report claims he was found hiding in the bushes near 600 Swartz Road in Akron, one half-mile away from the accident. Marijuana was seen on the dashboard.

Cleavenger is wanted out of Kansas for a felony warrant pending out-of-state matters. Ohio is out of the range for him to be arrested.

He has a history of run-ins with law enforcement. In addition to Ohio, his criminal record shows charges from Texas and Pennsylvania ranging from theft, drug abuse, vehicle and traffic violations.

Cleavenger was also charged in a brutal attack for felonious assault and abduction Jan. 4. His pretrial is Thursday, April 11 at 8:45 a.m. and the court hearing is Monday, April 29 at 9 a.m.

Officers from The Barberton Police Department declined to comment on these events.
